#### 18.10.02 Matters Arising

#### 2.1 - Asphalt Plant - City Hall Meeting

Many residents of the St. Margaret's Bay area attended Public Hearing Meeting on Tuesday October 16<sup>th</sup>, 2018 at City Hall. Councillor Matt Whitman put forward a motion that Halifax Regional Council refuse the proposed amendments to the Municipal Planning Strategy (MPS) and Land Use By-law (LUB) for Planning Districts 1 and 3, (St. Margaret's Bay) as set out in Attachments A and B of the staff report dated July 11, 2018, to permit an asphalt plant on a portion of PID# 41457821 north of Highway 103 and west of Little Indian Lake, Head of St, Margaret's Bay.

HRM staff presented their report, Scotian Materials presented their case, Councillors asked numerous questions of clarification, and approximately 25 residents voiced their opinion. Councillors voted 9 to 7 against the motion on the table.

An amended motion was put forward to limit operation of the asphalt plant to 60 days of continuous operation. An additional 30 days could be possible, but would need to be approved. This amendment was approved 12 to 4.

Nick Horne will consult with a lawyer to determine if there were any missteps with the process at the public hearing to establish if an appeal is possible, but chances are slim that there is anything more we can do.

The Board thanked Nick and Trevor for all their hard work on this project. Nick thanked the community for their support and on-going engagement.

2.2 – Garbage cans update (Melissa/Stephen) Stephen is following up with HRM via 311.

#### 2.3 – Scholarship Fund update (Richard and Justin)

Justin emailed Haliburton to see what they do for their Scholarship Awards. Haliburton has two awards for \$500 each that they award to two eligible high school students that have demonstrated positive contributions to their community. If WWH were to offer such a scholarship fund as well the suggestion would be that students would have to submit an essay for review by the WWHRA Board and the winners could be presented with their prize at the AGM.

**Nick** will send the contact information for the Scholarship Committee the Bay Treasure Chest to Richard and Justin so they can ask questions and get more procedural information.

Most board members were in agreement with this initiative. Others felt that perhaps it wouldn't be something the community, as a whole would want. There was a suggestion to bring the information to the 2019 AGM for a vote. If the proposal is brought to the AGM and the community agrees with initiating the scholarship then the students will have the 2019 summer and the 2019-2020 school year to volunteer and participate in the community events to build their portfolio and write their essay.

**MOTION**: Justin and Richard to provide more information regarding specifics and cost commitment before making a decision as to next steps.

# 3.2 - Evacuation Plan and Fire Prevention (Nola)

The WWH has an evacuation plan and it was launched in June 2018. Nola will be speaking to JEM in June 2019. The packages will be circulated to residents in the near future. Mock evacuation drill to be done sometime in the near future as well. Nola will follow up re the wildfire assessment. Having the trees cut down for the asphalt plant creates a natural firebreak for our subdivision.

#### 3.3 - Community Garden Project (Nick, Penelope, Trevor and Julie)

The meeting with Matt Whitman has not happened as yet.

Trevor discovered that Darrell Dixon has been trying to give HRM this land as a park credit, but HRM won't take it. Discussion ensued and it was decided that the WWHRA would investigate further to strongly encourage HRM to take over the land. From the perspective of HRM, insurance will be an issue. Trevor agreed to draft a letter of intent.

#### 3.4 - Community Sign Update (Dustin)

New sign needs to be placed in a slightly different location than the old sign to meet with current regulations. Variance is being worked on must be approved. Suggestion is to get Councillor Whitman involved to see where the variance application is in the process. Justin has some quotes for signage.

# 3.5 - New Playground (Shawn, Crystal and Nick)

There is no movement on this initiative at the present time until a location of the playground is determined.
